13	state of Texas, and		
14	WHEREAS, Section 545.356 of the Texas Transportation Code authorizes the		
15	governing body of a municipality to alter, by ordinance, prima facie speed limits		
16	pursuant to an engineering and traffic investigation, and		
17	WHEREAS, an engineering and traffic investigation was conducted on a portion		
18	of Kenney Fort Boulevard (northbound and southbound) beginning at Forest Creek		
19	Drive to SH 45 Frontage Roads, on February 25, 2025, and		
20	WHEREAS, a copy of said engineering and traffic study is attached hereto and		
21	incorporated herein for all purposes as Exhibit "A," and		
22	WHEREAS, the results of said engineering and traffic investigation indicate that		
23	certain speed zones on Kenney Fort Boulevard (northbound and southbound) beginning		
24	at Forest Creek Drive to SH 45 Frontage Roads, should be amended, Now Therefore		
25	BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROUND ROCK,
