THIS SUPPLEMENTAL AGREEMENT NO. 1 to "City of Round Rock Agreement for Professional Consulting Services Related to Investment Advisory Services with Valley View Consulting, L.L.C.," hereinafter called "Supplemental Agreement No. 1," is made by and between the CITY OF ROUND ROCK, a Texas home-rule municipal corporation, with offices located at 221 East Main Street, Round Rock, Texas 78664-5299 hereinafter called the "City," and VALLEY VIEW CONSULTING, L.L.C., with offices located at 2428 Carters Mill Road, Huddleston, Virginia 24104, hereinafter called the "Consultant."

WHEREAS, the City and Consultant executed the referenced "City of Round Rock Agreement for Professional Consulting Services Related to Investment Advisory Services," hereinafter called the "Agreement," by Resolution No. R-2021-247; and

WHEREAS, pursuant to Section 1.01 of the Agreement, the initial term of the Agreement was for twenty-four (24) months from the effective date thereof with two (2) allowable successive twenty-four (24) month renewal periods; and

WHEREAS, the City and Consultant desire to extend the term of the Agreement for the first of two (2) allowable consecutive twenty-four (24) month renewal terms; and

WHEREAS, the new renewal term shall become effective as of September 9, 2023, upon execution of this Supplemental Agreement No. 1; and

NOW THEREFORE, premises considered, and in consideration of the mutual promises and obligations in the Agreement and this Supplemental Agreement No. 1, the City and Consultant agree as follows:

Pursuant to Section 1.01 of the Agreement, the term of the Agreement is renewed for the first allowable twenty-four (24) month renewal period. The twenty-four (24) month renewal term shall commence upon expiration of the initial term of the Agreement.

II.

This Supplemental Agreement No. 1 embodies the first of two (2) allowable twenty-four (24) month renewal periods and shall extend the original Agreement as to time only with no other changes in terms or conditions of the original Agreement.

IN WITNESS WHEREOF, the City and Consultant have executed this Supplemental Agreement No. 1 to be effective as of the last date of due execution by both parties.
