WHEREAS, the Agreement states that the total amount of costs to be paid to Vendor shall not exceed \$1,500,000.00 for the term of the Agreement; and

WHEREAS, the parties desire to increase the Contract Amount by additional costs in the amount of \$2,000,000.00 as set forth herein;

NOW THEREFORE, premises considered, and in consideration of the mutual promises and obligations in the Agreement and this Supplemental Agreement No. 1, the City and Vendor agree as follows:

I.

Section 5.01, *Contract Amount*, is amended to read as follows:

In consideration for the goods and services to be performed by Vendor, the City agrees to pay the Vendor an amount not-to-exceed a total of **Three Million Five Hundred Thousand and No/100 Dollars (\$3,500,000.00)**.

This Supplemental Agreement No. 1 shall amend the original Agreement as to costs only as set forth herein, with no other changes in terms or conditions of the original Agreement.
