AN ORDINANCE AMENDING CHAPTER 44, SECTION 44-344, CODE OF ORDINANCES (2010 EDITION), CITY OF ROUND ROCK, TEXAS, REGARDING LEVY OF DRAINAGE UTILITY CHARGES; AND PROVIDING FOR A SAVINGS CLAUSE AND REPEALING CONFLICTING ORDINANCES AND RESOLUTIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROUND ROCK, TEXAS:

I.

That Chapter 44, Section 44-344(b)(3), Code of Ordinances (2010 Edition), City of Round Rock, Texas, is hereby amended to read as follows:

**Sec. 44-344. Levy of drainage utility charges.**

(b) *Fee calculation.*

(3) *Schedule of monthly fees and rates.* The monthly drainage utility charge shall be as follows:

a. *Residential units.* The monthly drainage utility charge for each residential dwelling unit or ERU shall be as follows:

Effective Date	Monthly Fee
<del>March 1, 2011</del> <u>March 1, 2014</u>	<del>\$2.75</del> <u>\$4.75</u>

b. *Nonresidential units.* The monthly drainage utility charge for the impervious area measured in square feet on each nonresidential parcel shall be as follows:

Effective Date	Rate (per ERU)
<del>March 1, 2011</del> <u>March 1, 2014</u>	<del>\$2.75</del> <u>\$4.75</u>

3 **A.** All ordinances, parts of ordinances, or resolutions in conflict herewith are

6 invalidate other sections or provisions thereof.
