	In 2022, Round Rock conducted thorough inspections of our wastewater lines due to increased flow rates at our wastewater treatment plant (WWTP). During this process, we discovered that a dry utility company had inadvertently drilled through the regional 84-inch wastewater interceptor near Brushy Creek and I-35. After engaging with multiple companies, we identified it as an MCI (Version) line. Working closely with Michael Bennett, City ownership was confirmed. The affected section of wastewater pipe lies 28 feet deep within rock and was originally installed using tunneling techniques. Unfortunately, open excavation is not feasible for accessing this location. Instead, we must utilize a manhole situated 960 feet away. Given that this project is not a standard repair, Round Rock cannot complete this repair in house. The repair warrants specialized methods that involves live entry into the wastewater main to cut and seal the damaged pipe.
