CHAPTER 1. INTRODUCTORY PROVISIONS

17 Sec. 1-50. - Definitions.

Term	Definition
Sports training facility/specialty gym	A facility, wholly enclosed within a building, designed for individual training in team sports or fitness-related activities. Includes baseball, gymnastics, martial arts, cheerleading, rock climbing, weightlifting, game courts and other fitness-related activities facilities. Does not include Indoor Entertainment Activities.
