F. CERTIFICATE OF APPROPRIATENESS

- F.1** Consider a presentation and action regarding a Certificate of Appropriateness for 200 Round Rock Avenue, HP24-000018.

Planner Kerstin Harding presented the staff analysis for the Town Green project, a new outdoor public space to encompass the entirety of Block 23, bounded by Mays, Main, Liberty, and Blair streets.

She noted that the Commission only has purview over the parts of the site that have H overlay zoning. One of these parts includes the Water Tower and the other was the site of the Telephone Exchange building, which was moved to another location in 2018, so the lot is currently vacant. There is also one historically significant structure that does not have H overlay: the Johnson building or old gas station at the southeast corner. This building will be restored to its original 1938 size to provide a covered area under the canopy and to house restrooms within. The project also incorporates an existing tree-lined sidewalk that marks the location of the Round Rock Avenue right-of-way that was closed when the traffic circle was completed in 2016.

Since the project does not involve alterations to the Water Tower, only alterations to the landscape around it, this could be reviewed administratively, but since it is a high-profile project it is being presented to the Commission. Since the Water Tower is the only structure with H overlay the project should be reviewed for whether the project enhances or detracts from the Tower's historic character. The Commission may discuss anything about the project, but the motion could only relate to areas with H overlay zoning.

Parks Development Manager Katie Baker took the podium to describe the Town Green project and answer Commissioners’ questions.

A motion was made by Commissioner Wolfe and seconded by Commissioner Conrad to approve the Town Green project as presented, with the caveat that staff may have the final review over any changes. The motion carried by the following vote:
