THIS SUPPLEMENTAL AGREEMENT NO. 1 to "City of Round Rock Agreement for the Purchase of OEM Ford Replacement Parts" called "Supplemental Agreement No. 1," is made by and between the CITY OF ROUND ROCK, TEXAS, a home-rule municipality, with offices located at 221 East Main Street, Round Rock, Texas 78664-5299 (referred to herein as the "City"), and MAC HAIK FORD LINCOLN, whose mailing address is P.O. Box 710, Georgetown, Texas 78627-0710 (referred to herein as "Vendor").

WHEREAS, the City and Vendor previously executed the referenced "City of Round Rock Agreement for the Purchase of OEM Ford Replacement Parts," hereinafter called the "Agreement" on May 28, 2020 by Resolution No. R-2020-0143; and

WHEREAS, the Agreement states that the total amount of costs to be paid to Vendor shall not exceed \$650,000.00 for the term of the Agreement; and

WHEREAS, the parties desire to increase the Contract Amount by an additional \$162,500.00 as set forth herein;

**NOW THEREFORE,** in consideration of the mutual promises and obligations in the Agreement and this Supplemental Agreement No. 1, the City and Vendor agree that said Agreement is amended and supplemented as follows:

I.

## Section 5.01(B), *Costs*, is amended to read as follows:

B. The City shall be authorized to pay Vendor an amount not-to-exceed **Eight Hundred Twelve Thousand Five Hundred and No/100 Dollars (\$812,500.00)** for the term of this Agreement.

This Supplemental Agreement No. 1 shall amend the original Agreement only as set forth herein with no other changes in terms or conditions of the original Agreement.

IN WITNESS WHEREOF, the City and Vendor have executed this Supplemental Agreement No. 1 to be effective as of the last date of due execution by both parties.
