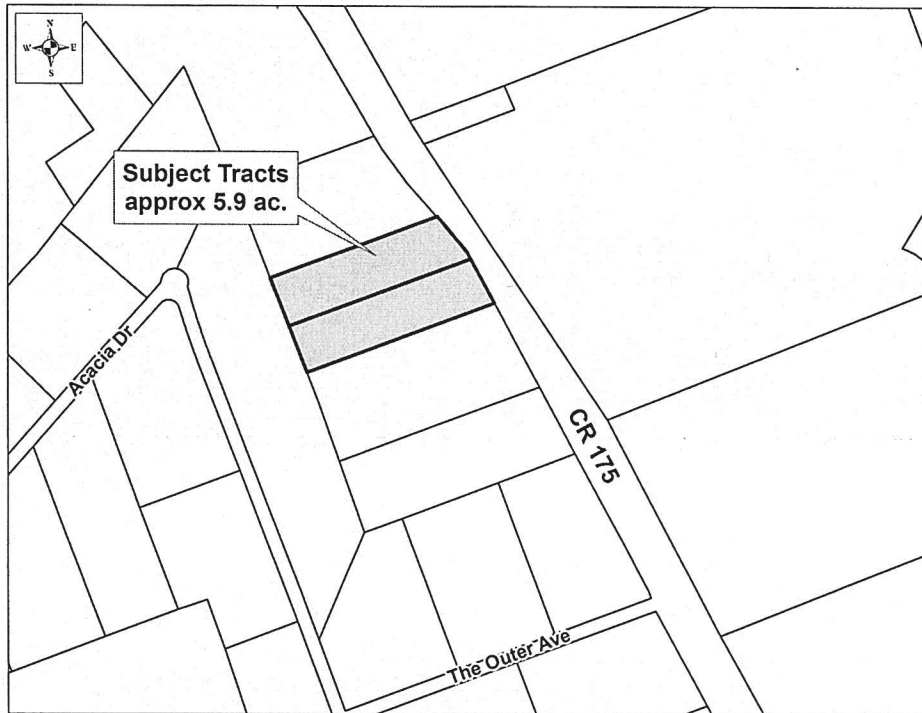

HISTORY: There is no legislative history on this parcel.

DATE OF REVIEW: February 1, 2017

LOCATION: West side of County Road 175, north of Perry Mayfield

STAFF REVIEW AND ANALYSIS:

General Plan and Zoning: The plat site's general plan designation is residential. This plat is located in the city's Extraterritorial Jurisdiction and is not subject to the city's zoning ordinance.

Traffic, Access and Roads: The plat site fronts directly on County Road 175. The city's Transportation Department will not require a traffic impact analysis for this plat due to the proposed use not meeting the trip threshold to require such a study.

Water and Wastewater Service: The property will be served by on-site well and septic systems.

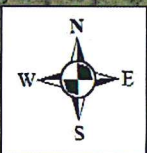
Drainage: A detention pond is proposed for the southeast corner of the plat. The pond will feed into a nearby ditch. TCEQ will permit the water pollution abatement plan for the site.

Additional Considerations: The plat is required due to the need for an on-site sewage facilities permit for the proposed church building addition. The applicant will need to obtain signatures of the Williamson County Health District and County Engineer prior to the Planning and Zoning Commission Chairman signing the plat and recordation. This application qualifies as a minor plat due to having two or fewer lots, not needing a Traffic Impact Analysis and not requiring any offsite public improvements.

RECOMMENDED MOTION:

Staff recommends approval with the following conditions:

1. Correct ownership in data table and in owner's preamble and signature.
2. Obtain signatures of Williamson County Engineer and Williamson County Health District prior to Planning and Zoning Commission Chairman signing the plat.



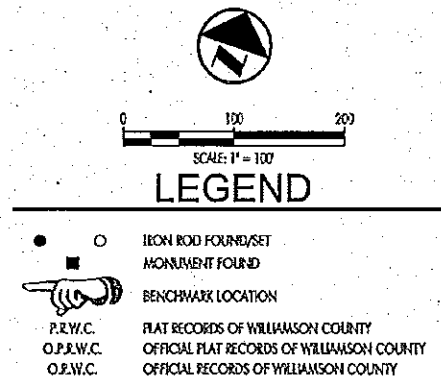

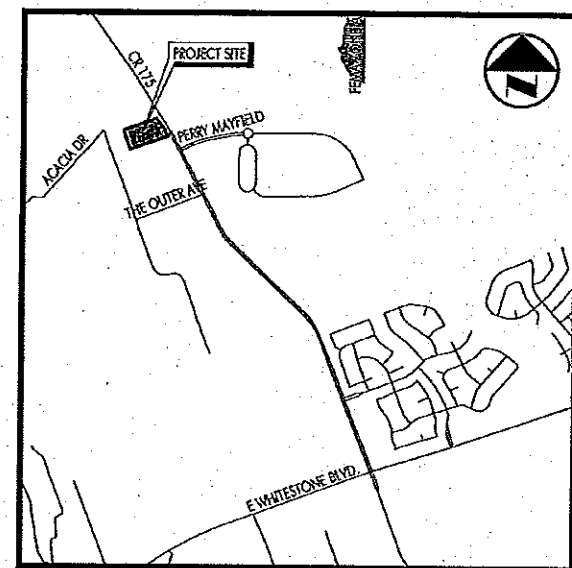
