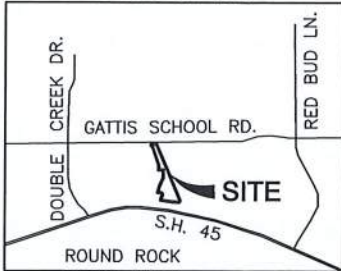

LOCATION MAP

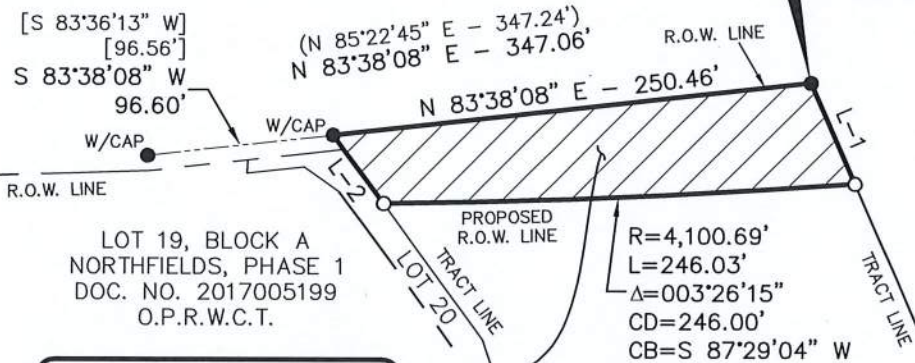

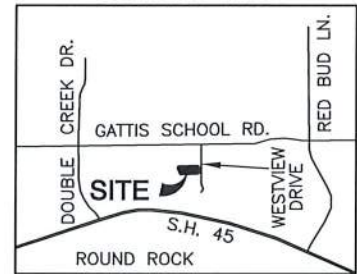

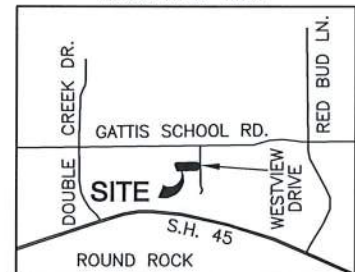
