### Planning and Development Services Dept.

Chair Anderson resigned from the HPC effective March 10, 2025. Vice-Chair Whitaker has automatically become chair and a new vice-chair will be elected at the April HPC meeting.

## **HPC Training:**

- Commissioners adopted a goal to each solicit a new nomination this year. #### Downtown Mixed-Use Zoning:

- The City is reevaluating its Downtown Mixed-Use zoning districts which include many historic properties. Staff are currently summarizing all of the public input collected. Updates will be posted on <a href="mailto:roundrocktexas.gov/downtownzoning">roundrocktexas.gov/downtownzoning</a>.
- As part of this project, PDS reached out the 125 property owners whose properties are older than 50 years but are not currently designated. The outreach had a 12% response rate. Staff are scheduling meetings with interested property owners to discuss the historic preservation program and designation process. As of 4/11, staff have met with 6 property owners and are coordinating meetings with an additional 5 property owners.



Updates on properties with H Overlay:

- 803 E Liberty Ave:
  - #100: A metal handrail was added to the front porch. The handrail was not required by code but requested by tenant.
  - #300: The garage conversion from an office to an apartment was completed and received its Certificate of Occupancy.
- 609 E Liberty Ave: A predevelopment meeting was held to discuss the proposal for a new garage with 2<sup>nd</sup> floor apartment. Staff anticipate a CofA application for the project within a few months.



- **206 E Main St:** The HPC approved the conversion of a back window to a door in HP24-000003. The work has been completed; however, staff do not believe the door meets the conditions of the CofA. Staff will be meeting with the contractor's representatives to discuss remedies.
- Griffith building (former library) was approved by the HPC on 8/17/23 and granted staff purview to review any alterations to the plans. Staff issued a minor amendment to the CofA for the mortar selection for the brick portion of the west and south elevation which changed from white to charcoal gray. The raised pedestrian crossing that connects Prete Plaza to the Paseo is now complete. This project was reviewed because the H overlay for the historic district includes the Main Street right-of-way.



## Parks and Recreation Dept. (PARD)

PARD is revisiting restoration plans for the Sansom House/Cantina next to the Stagecoach Inn to assess whether they are still applicable should funding become available in the future. A set of plans for restoration was last reviewed by the HPC in 2013.

Heritage Trail West is now complete. The interpretive signage, which was originally included under this contract, will be placed under a new contract and will be completed in the near future. Staff are working with PARD to review the interpretive signage for the trail.



On February 8, 2024, City Council approved an agreement to continue the development of the Downtown Park (formerly Lawn at Brushy Creek). The Downtown Park agreement also encompasses the design and administration of the Town Green Project which includes enhancements to the area around the water tower and the Johnson Building (gas station). These improvements are included under the same contract as the Downtown Park but will be completed at a later time. Construction of the Town Green Project, including the Johnson Building, is anticipated to begin this summer.

## **General Services Dept.**

The Palm House was relocated from 212 E Main Street to the Old Settlers Association grounds on January 30, 2024. The house has been moved onto its new foundation piers and the chimney has been reassembled. Heimsath Architects developed a preservation program and restoration plan for the house which was reviewed by the THC. The HPC will review these plans at the April 15 meeting.

## **Round Rock Preservation (RRP)**

RRP held their annual General Meeting on April 12.

RRP met with city staff to discuss the use of the Stagecoach Inn on March 5.
