16	pursuant to an engineering and traffic investigation, and
17	WHEREAS, an engineering and traffic investigation was conducted on a portion
18	of University Boulevard (eastbound and westbound) beginning at IH 35 to SH 130, on
19	the 4th day of October, 2023, and
20	WHEREAS, a copy of said engineering and traffic study is attached hereto and
21	incorporated herein for all purposes as Exhibit "A," and
22	WHEREAS, the results of said engineering and traffic investigation indicate that
23	certain speed zones on University Boulevard (eastbound and westbound) from IH 35 to
24	the SH 130, should be amended, Now Therefore
