

ORDINANCE NO. O-2023-178

AN ORDINANCE AMENDING CHAPTER 32, ARTICLE II, SECTION 32-33, GARBAGE COLLECTION SERVICE CHARGES, CODE OF ORDINANCES (2018 EDITION), CITY OF ROUND ROCK, TEXAS, REGARDING DOWNTOWN COMMERCIAL DISTRICT CHARGES; AND PROVIDING FOR A SAVINGS CLAUSE AND REPEALING CONFLICTING ORDINANCES AND RESOLUTIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROUND ROCK, TEXAS:

I.

That Chapter 32, Article II, Section 32-33(c)(3), Code of Ordinances (2018 Edition), City of Round Rock, Texas, is hereby amended to read as follows:

Sec. 32-33. – Garbage collection service charges.

(c) Downtown commercial district.

(3) The charge for the collection of refuse and recycling for businesses in the downtown commercial district shall be determined based on the classification and square footage of a business as follows:

Small Office	6500 or less	\$35.00 <u>17.35</u>
Large Office	6501 or more	\$69.00 <u>34.70</u>
Small Retail and Services	3000 or less	\$69.00 <u>34.70</u>
Large Retail and Services	3001 or more	\$110.00 <u>184.00</u>
<u>Small Specialty</u>	<u>1600 or less</u>	<u>\$113.64</u>
<u>Medium Specialty</u>	<u>1601-3000</u>	<u>\$158.85</u>
<u>Large Specialty</u>	<u>3001 or more</u>	<u>\$248.68</u>
Small Restaurant	1600 or less	\$187.00 <u>184.00</u>
Medium Restaurant	1601-3000	\$256.00 <u>248.68</u>
Large Restaurant	3001 or more	\$326.00 <u>317.29</u>
Small Bar	2500 or less	\$166.00 <u>163.00</u>

An administrative fee equal to \$3.10 or ten percent (10%) of the collection charge, whichever is greater, shall be added to the charges listed above for each business in the downtown commercial district.

II.
