This Supplemental Agreement No. 3 to "City of Round Rock 'Software as a Service' & Professional Consulting Services Agreement with PerfectMIND Inc.," hereinafter called the "Supplemental Agreement," is made by and between the City of Round Rock, Texas, a Texas home-rule municipality, whose offices are located at 221 East Main Street, Round Rock, Texas 78664-5299, hereinafter called "City," and PerfectMind Inc, whose offices are located at 2nd Floor, 4333 Still Creek Drive, Burnaby British Columbia, Canada VSC 6S6, hereinafter called "PerfectMIND."

WHEREAS, City and PerfectMIND (collectively the "parties") previously executed the referenced "City of Round Rock 'Software as a Service' & Professional Consulting Services Agreement," for parks and recreation program management software, hereinafter called the "Agreement," on November 12, 2015 by Resolution No. R-2015-2867; and

WHEREAS, the parties previously executed two (2) term renewals on December 17, 2020 by Resolution No. R-2020-03 and on November 18, 2021 by Resolution No. R-2021-306; and

WHEREAS, the parties desire to extend the term of the Agreement for an additional twelve (12) months commencing upon the expiration of the second renewal term;

NOW THEREFORE, premises considered, and in consideration of the mutual promises and obligations in the Agreement and this Supplemental Agreement No. 3, the City and PerfectMIND agree as follows:

I.

The term of the Agreement is extended for an additional twelve (12) month period commencing upon the expiration of the second renewal term.

II.

The parties agree that the City will pay Platform Use Fees during this extension in the amount of Sixty-Eight Thousand Nine Hundred Fifty and No/100 Dollars (\$68,950.00).

Payment shall be due in advance of the twelve (12) month renewal period as set forth in Section 4.2 of the Agreement.

III.

This Supplemental Agreement No. 3 shall extend the original Agreement and modify fees as set forth herein with no other changes in terms or conditions of the original Agreement.

IN WITNESS WHEREOF, the City and PerfectMIND have executed this Supplemental Agreement No. 3 to be effective as of the last date of due execution by both parties.
