It is important for a town, especially one that is growing as fast as Round Rock is, to protect its history. I would be very sad if this building were lost just to straighten out a road.
- 3/24/16 **Subject**: Please Save the RR Stage Coach Inn **Body**: I want to share my serious concern about the plan to destroy or move this amazing Texas (and Round Rock) historical treasure.

The builder of the Round Rock Stage Coach Inn, John J. Harris, is my great-great grandfather on my fathers side. Over many years our family has taken significant pride from this connection and the Inns impact in Texas history. This was a highlight story told in my family throughout the years at family gatherings. I am a very (typical) prideful Texan who highly values our great states unique history.

John J. Harris' descendants settled in Stephenville, TX. John J's son, John P. Harris, raised 4 sons in Stephenville. We still have land and the property there where they raised 3 generations of our family.

I am in favor of keeping the property preserved in its current location. I understand that "all options" have been apparently considered, but I doubt that the interests of the Inn have taken proper priority over traffic and other considerations. I certainly recognize the complexities involved. I don't feel moving it is a good approach, posing major risk to the integrity and beauty of the structure. Moving the Inn also changes the inherent historic nature of the location...right on the Chisholm Trail, a foundational piece of Texas history.

I welcome further discussion or forums to revisit the end gameplan. Please advise on the specific opportunities for input and the upcoming sequence of events.

I showed up at City Hall the other day for the meeting as soon as I got off of work to hear what is to become of this FANTASTIC landmark, but I guess I had just missed the meeting since I got off of work so late? Did it end really early?? Is there another meeting coming up soon at which the fate of this landmark will be discussed?

I am blown away by the fact that the Old Stagecoach Inn is NOT a protected historic landmark already (It apparently ISN'T, is it??). How did THAT happen? And can that be CHANGED at this point?

This is an atrocity to stomach, considering that this is a landmark that is as innocent at the times of old.....symbolic of what made America great, when people fought hard to create a better life for themselves and for the future generations to come.

I feel VERY strongly that straightening a roadway will not cause traffic to flow more freely, as long as people hold cell phones in-hand while driving. The historic building is not the issue: it's distracted driving.....PERIOD. Ever drive on the toll road in the mornings or in the evenings at peak traffic hours? How many lanes wide is that thing at its NARROWEST, and what is the average speed limit of said toll road??

Yet, when in the thick of traffic hours, I still find myself stuck going 55 on the toll road behind the ever-present "rolling road block" of which Austin's distracted drivers comprise the ENTIRETY of the traffic congestion.

Same story with 620. You could pave a twenty lane highway right there, tear down every historic building along its path - one year old to one HUNDRED years old, and I bet I'll STILL be stuck in traffic behind "Mr. and Mrs. I-Phone User", and the span of nineteen cars driving in a straight line alongside of them in like fashion, each with cell phones in-hand in a ginormous rolling road block.

Just today, as a matter of fact, as I drove westbound on 620 form I-35, just before the Chisholm Trail intersection, an 18-wheeler driver (to his credit, he was at LEAST in the right/slow lane), didn't bother to peak above 20 mph, even long after he drove through the green light there; he peaked at 20 mph long after that light had turned green without regard to the one hundred people stacked up behind him. It looked like he was checking his FaceBook while driving or something, and didn't care at ALL who needed to be where at what time.

PLEASE do what you can to get the word out that this is not the solution to the problem, the mere straightening of a roadway alone, nor would the widening of it, as is exemplified in the nearly daily story of my daily toll road ventures.

What can I do as an individual to help with this - to make the Old Stagecoach Inn invincible, the way it should have been from the get-go?

Let's not destroy history for the promise of "progress" that, in the end, will amount to no better results, anyway. It takes but only two distracted drivers driving side-by-side in the two available lanes, driving in each direction, to cause a traffic jam.....not some silly CURVE in a roadway.

3/17/16 **Subject:** The Old Stagecoach Inn **Body:** In Portugal, there are several similar buildings of stone that the Portuguese government has turned in to bed and breakfasts called "pousadas". There are manor houses, monasteries, and castles. I think they started doing this around the 1940s until around 2003 when they were privatized. It's a source of revenue and creates jobs.

If it must be moved, there is a great spot near Egger Park which is across from Advanced Auto Parts on South Mays. The property has a stone wall around part of it, and is close to McNeil and I-35.

The traffic, however, is another issue, and I feel that the Stagecoach Inn is worth saving and is not a contributing factor to the traffic congestion. Although it seems folks are wanting to build a bridge because of the train regardless of the reasons, they could extend Lakewood Lane east to the frontage road (south of Sprouts) to bypass the RR tracks.

Furthermore, Wonder Rd. and Clark Street could be extended south to 620 so that traffic can bypass the tracks and head north to Sam Bass. This area is industrial so folks aren't disturbing a residential neighborhood.

Anyway, it's worth researching solutions that are working around the country. I've had to do similar in the past, and it was worth the effort as I was able to find solutions for the problem at the time. The good thing is, research is much easier now-information comes to you, and from a wider range than just input from locals.

Good luck and I hope things work out. It's a beautiful piece of history and worth saving.
