This SUPPLEMENTAL AGREEMENT NO. 1 to "City of Round Rock Agreement for Consulting Services for Building Construction Projects" (the "Agreement") is made by and between the City of Round Rock, Texas (hereinafter referred to as the "City"), and Karl Kietzke (hereinafter referred to as "Consultant").

RECITALS:

WHEREAS, the City and Consultant previously executed an Agreement (hereinafter referred to as the "Agreement") for provision of building consulting services for certain City construction projects; and

WHEREAS, it has now become necessary to amend the Agreement to modify the term and increase the not-to-exceed fee as a result of an increase in the scope of services, specifically the addition of building construction consulting services related to the Old Settlers Park Multi-Purpose Field Complex Project;

NOW, THEREFORE, premises considered, the City and Consultant agree that said Agreement is amended as follows:

T.

Section 1.01 of the Agreement shall be amended as follows:

B. The term of this Agreement shall expire upon successful completion of the services, which is estimated to be approximately nine (9) months from the effective date no later than August 31, 2017.

II.

Section 1.03 of the Agreement shall be amended as follows:

A. The consulting fee shall be Seventy-Five and No Cents (\$75.00) per hour, not-to-exceed Fifty Thousand Dollars and No Cents (\$50,000.00) One Hundred

Thousand Dollars and No Cents (\$100,000.00).

III.

With the exception of the terms set forth herein, there shall be no other changes in the terms or conditions of the original Agreement and those such terms and conditions shall remain effective.
