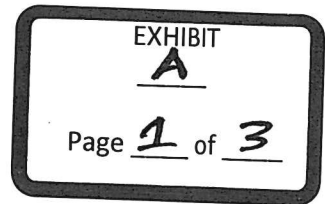

**FIELD NOTES FOR 5.1875 ACRES OF LAND OUT OF THE
ASA THOMAS SURVEY, ABSTRACT NO. 609 IN
WILLIAMSON COUNTY, TEXAS, BEING THE SAME TRACT
CONVEYED TO FARID AGAHI BY DEED RECORDED IN
DOCUMENT NO. 2013003398, OFFICIAL PUBLIC RECORDS,
WILLIAMSON COUNTY, TEXAS, SAID 5.1875 ACRE TRACT
BEING MORE PARTICULARLY DESCRIBED BY METES AND
BOUNDS AS FOLLOWS:**

BEGINNING at a ½" iron rod set in the South R.O.W. line of Gattis School Road, being the North common corner of this tract and a 5.27 acre tract conveyed to Lloyd R Rodenbeck, Jr. et ux by deed recorded in Document No. 1999075263, Official Public Records, Williamson County, Texas, for the Northeast corner of this tract and the **POINT OF BEGINNING**, whence a ½" iron rod found for the Northeast corner of said 5.27 acre tract bears N87°01'12"E a distance of 338.45 feet and a ½" iron rod found bears S11°11'13"E a distance of 2.01 feet;

THENCE S18°43'05"E with the common line of this tract and said 5.27 acre tract a distance of 793.24 feet to a ½" iron rod found in the North line of a 5.540 acre tract conveyed to Richard Nord by deed recorded in Volume 906, Page 289, Deed Records, Williamson County, Texas, for the Southeast corner of this tract;

THENCE S87°52'51"W with the common line of this tract and said 5.540 acre tract a distance of 264.31 feet to a ½" iron rod found in the East line of a 6.527 acre abandoned railroad R.O.W. tract owned by the State of Texas (no deed found), for the Southwest corner of this tract;

THENCE N23°44'12"W with the common line of this tract and said 6.527 acre tract a distance of 796.58 feet to a ½" iron rod set in the South R.O.W. line of said Gattis School Road, for the Northwest corner of this tract;

THENCE N84°29'13"E with the South R.O.W. line of said Gattis School Road and the North line of this tract a distance of 331.75 feet to the **POINT OF BEGINNING** and containing 5.1875 acres of land, more or less.

I hereby certify that the foregoing field notes were prepared from a survey on the ground, under my supervision, and are true and correct to the best of my knowledge and belief.

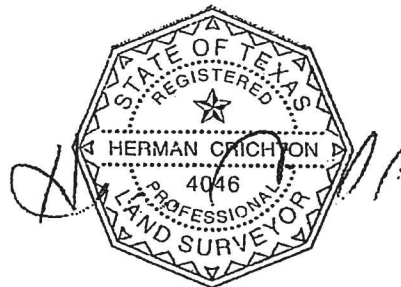

THENCE, south, with the east line hereof, and being the common line of said tract and the west line of the McCrary tract as described in Volume 905, at Page 485 among the DEED RECORDS of said county and state

S 11° 16' 50" E, 780.76 feet

to a 1/2 inch rebar found in the north line of the Nord tract as described in Volume 906, at Page 289, among the DEED RECORDS of said county and state, for the southeast corner hereof and of said tract;

THENCE, leaving said line and continuing west with the south line hereof

S 90° 00' 00" W, 263.63 feet

to a 3/8 inch rebar found at the common south corner hereof and of the Houston tract as described in Volume 743, at Page 647 among the DEED RECORDS of said county and state, for the southwest corner hereof;

THENCE, leaving said line and continuing north with the west line hereof and being common to said Houston tract

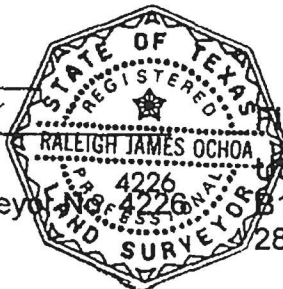
to a 1/2 inch rebar set in said south right-of-way line for the northwest corner hereof and being common to said Save and Except tract;

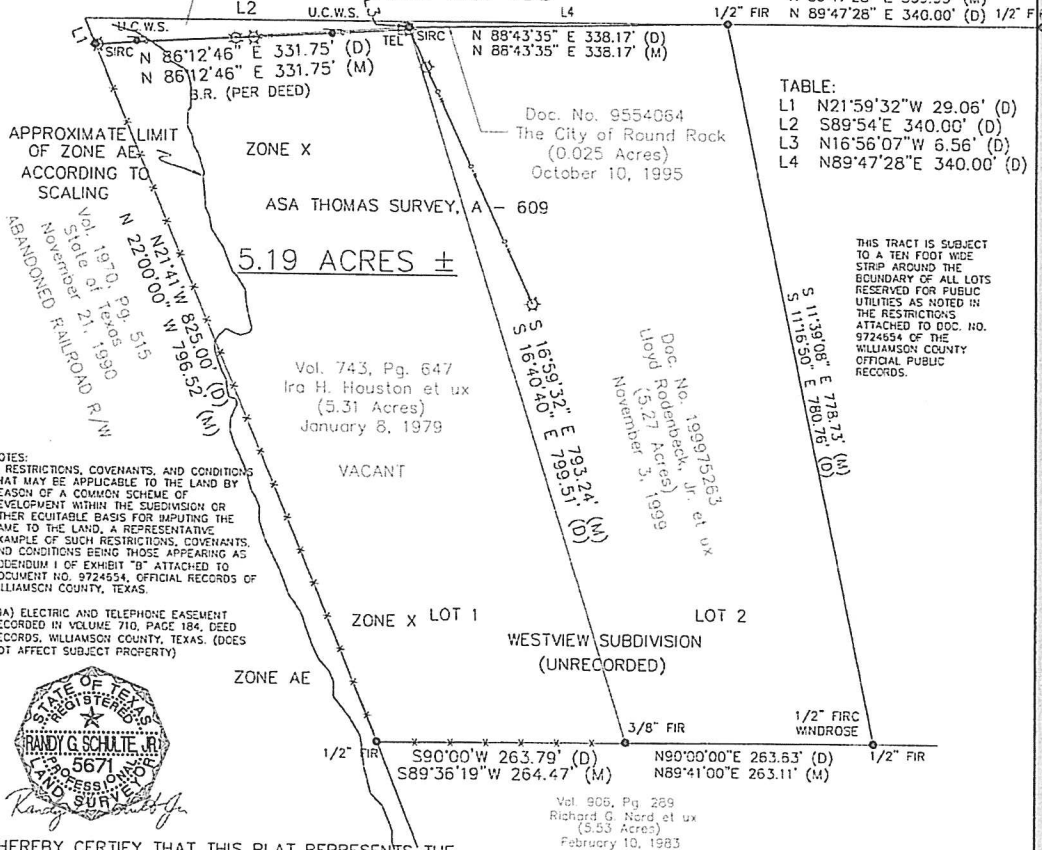
