## **RESOLUTION NO. R-2017-4218**

## A RESOLUTION AUTHORIZING THE NEGOTIATION, EXECUTION, AND DELIVERY OF LEASE AGREEMENT WITH TCF EQUIPMENT FINANCE DIVISION; LEASE SCHEDULE; PAYMENT SCHEDULE; AND RELATED INSTRUMENTS, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the City of Round Rock, Texas, 221 East Main Street, Round Rock, Texas 78664 (the "Lessee") proposes to enter into Lease No. 008-0713107 with TCF Equipment Finance, a division of TCF National Bank, 1111 West San Marnan Drive, Suite A2 West, Waterloo, Iowa 50701-8926 (the "Lessor"); and

WHEREAS, the principal amount expected to be financed is \$265,117.50; and

WHEREAS, Lessee is a political subdivision of the State of Texas in which Lessee is located (the "State") and is duly organized and existing pursuant to the constitution and laws of the State of Texas; and

WHEREAS, pursuant to applicable law, the governing body of Lessee ("City Council") is authorized to acquire, dispose of and encumber real and personal property including, without limitation, rights and interests in property, leases and easements necessary to the functions or operations of Lessee; and

WHEREAS, the City Council desires to obtain certain equipment described in the "Equipment Schedule" to the Lease in an amount not to exceed \$265,117.50 (collectively the "Lease") with TCF Equipment Finance, a division of TCF National Bank; and

WHEREAS, the City Council hereby finds and determines that the execution of the Lease in the principal amount not exceeding the amount stated above ("Principal Amount") for the purpose of leasing with the option to purchase property described specifically in the

Equipment Schedule is appropriate and necessary to the functions and operations of Lessee, and that the Equipment is essential for Lessee to perform its governmental functions; and

**WHEREAS,** the Lease shall not constitute a general obligation indebtedness of the Lessee within the meaning of the Constitution,

## BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROUND ROCK, TEXAS,

Section 1. That the Mayor ("Authorized Representative") acting on behalf of Lessee is hereby authorized to negotiate, enter into, execute, and deliver the Lease and other related documents in substantially the form set forth in Exhibit "A" and presently before the City Council, attached hereto and incorporated herein, which document is available for public inspection at the office of the Lessee. Each Authorized Representative acting on behalf of Lessee is hereby authorized to negotiate, enter into, execute, and deliver such other documents relating to the Equipment Lease as the Authorized Representative deems necessary and appropriate. All other related contracts and agreements necessary and incidental to the Equipment Leases are hereby authorized.

Section 2. That by a written instrument signed by an Authorized Representative, said Authorized Representative may designate specifically identified officers or employees of Lessee to execute and deliver agreements and documents relating to the Equipment Leases on behalf of Lessee.

**Section 3.** That the aggregate original principal amount of the Equipment Leases shall not exceed the Principal Amount and shall bear interest as set forth in the Equipment Leases and the Equipment Leases shall contain such options to purchase by Lessee as set forth therein.

**Section 4.** The Lessee's obligations under the Equipment Leases shall be subject to annual appropriation or renewal by the City Council as set forth in each Equipment Lease and the Lessee's obligations under the Equipment Leases shall not constitute a general obligation of the Lessee or indebtedness under the constitution of the laws of the State of Texas.

Section 5. This Resolution shall take effect immediately upon its adoption and approval.

The City Council hereby finds and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution was adopted was posted and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter hereof were discussed, considered and formally acted upon, all as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.
