THIS SUPPLEMENTAL AGREEMENT NO. 1 to "City of Round Rock Agreement for Professional Consulting Services with Valley View, L.L.C.," hereinafter called "Supplemental Agreement No. 1," is made by and between the City of Round Rock, Texas, a home-rule municipality, hereinafter called the "City" and Valley View Consulting, L.L.C. hereinafter called the "Consultant."

WHEREAS, the City and Consultant executed the referenced "City of Round Rock Agreement for Professional Consulting Services," hereinafter called the "Agreement," on September 10, 2015 by Resolution No. R-2015-2798; and

WHEREAS, pursuant to Section 1.01 of the Agreement, the initial term of the Agreement was for twenty-four (24) months from the effective date thereof with two (2) allowable successive twenty-four (24) month renewal periods; and

WHEREAS, the initial term of the Agreement expires on September 10, 2017; and

WHEREAS, the parties desire to extend the term of the Agreement for the first of two (2) allowable consecutive twenty-four (24) month renewal terms; and

NOW THEREFORE, premises considered, and in consideration of the mutual promises and obligations in the Agreement and this Renewal Agreement, the City and Services Provider agree as follows:

I.

Pursuant to Section 1.01 of the Agreement, the term of the Agreement is renewed for the first allowable twenty-four (24) month renewal period. The twenty-four (24) month renewal term shall commence upon expiration of the initial term of the Agreement.

This Renewal Agreement embodies the first of two (2) allowable twenty-four (24) month renewal periods and shall extend the original Agreement as to time only with no other changes in terms or conditions of the original Agreement.

IN WITNESS WHEREOF, the City and Services Provider have executed this Renewal Agreement to be effective as of the last date of due execution by both parties.
