

RESOLUTION NO. 2018-5954

A RESOLUTION READOPTING AMENDMENTS TO “APPENDIX A: FEES, RATES AND CHARGES” TO THE CODE OF ORDINANCES, CITY OF ROUND ROCK, TEXAS (2010 EDITION) RELATED TO PARKS AND RECREATION FEES, PREVIOUSLY ADOPTED BY RESOLUTION NO. R-2018-5346; AMENDING “APPENDIX A: FEES, RATES AND CHARGES” TO THE CODE OF ORDINANCES, CITY OF ROUND ROCK, TEXAS (2018 EDITION) TO INCORPORATE SAID AMENDMENTS.

WHEREAS, the City of Round Rock (the “City”), as a Texas home-rule municipality, passes general and permanent legislation by adopting ordinances for the good government, peace, and order of the municipality; and

WHEREAS, the City previously had all such ordinances codified in its “Code of Ordinances, 2010 Edition;” and

WHEREAS, “Appendix A: Fees, Rates, and Charges” is a part of the City’s Code of Ordinances; and

WHEREAS, the City has formally adopted “Code of Ordinances, 2018 Edition;” and

WHEREAS, a resolution was previously adopted by the City amending “Appendix A: Fees, Rates, and Charges” related to Parks and Recreation Fees, and said amendment to the Fees was not incorporated in “Appendix A: Fees, Rates, and Charges,” to the Code of Ordinances, 2018 Edition; and

WHEREAS, said resolution requires re-adoption for incorporation into the Code of Ordinances, 2018 Edition; and

WHEREAS, the incorporation of said previously adopted amendments requires an amendment to “Appendix A: Fees, Rates and Charges,” to the Code of Ordinances, 2018 Edition as set forth herein; Now, Therefore

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROUND ROCK,
TEXAS,**

I.

The amendments to “Appendix A: Fees, Rates, and Charges” to Code of Ordinances, 2010 Edition, adopted by Resolution No. R-2018-5346 are hereby readopted and incorporated into the “Appendix A: Fees, Rates, and Charges” to the Code of Ordinances, 2018 Edition.

II.

That “Appendix A: Fees, Rates and Charges” to the Code of Ordinances, 2018 Edition, related to Chapter 29 – Parks and Recreation, is hereby amended to read as shown on Exhibit A, hereto attached and incorporated herein.

III.

The City Council hereby finds and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution was adopted was posted and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter hereof were discussed, considered and formally acted upon, all as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.
