## METES AND BOUNDS DESCRIPTION

BEING 30.36 ACRES OF LAND, OUT OF THE WILLIS DONAHO SURVEY, ABSTRACT NUMBER 173 IN WILLIAMSON COUNTY, TEXAS AND BEING A PORTION OF A 134.62 ACRE TRACT OF LAND CONVEYED TO CRESSMAN ENTERPRISES, L.P. BY INSTRUMENT OF RECORD IN DOCUMENT NUMBER 2003063811 OF THE OFFICIAL PUBLIC RECORDS OF WILLIAMSON COUNTY, TEXAS, THEREIN DESIGNATED AS "TRACT 3," AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 1/2" iron pipe found for the northwest corner of said 134.62 acre tract, being in the east line of a 33.302 acre tract of land conveyed to the State of Texas by instrument of record in Volume 1970, Page 515 of the Official Records of Williamson County, Texas and known therein as "Part 7" and being in the south right-of-way line of County Road Number 113 (Kiphen Road – R.O.W varies); from which a 1" iron pipe found in the west line of said 33.302 acre tract and being in the south right-of-way line of said County Road Number 113 bears South 73°14'36" West a distance of 108.35 feet;

THENCE along the north line of the 134.62 acre tract and the south right-of-way line of County Road Number 113 the following two (2) courses:

- 1. North 67°57'23" East a distance of 347.32 feet (record: North 70°35' East a distance of 347.32 feet) to a 1/2" rebar set with plastic cap, stamped "BASELINE, INC.";
- 2. North 68°37'07" East a distance of 42.92 feet (record: North 71°14'44" East a distance of 42.92 feet to a calculated point;

THENCE crossing through the 134.62 acre tract the following five (5) courses:

- 1. South 21°40"38" East a distance of 148.12 feet to a calculated point for a point of curvature;
- 2. Along a tangential curve to the left having a radius of 470.00 feet, a length of 379.77 feet, a delta angle of 46°17'46" and a chord which bears South 44°49'31" East a distance of 369.52 feet to a calculated point for a point of tangency;
- 3. South 67°58'24" East a distance of 144.61 feet to a calculated point for a point of curvature;
- 4. Along a tangential curve to the right having a radius of 470.00 feet, a length of 457.87 feet, a delta angle of 55°49'01" and a chord which bears South 40°03'53" East a distance of 439.98 feet to a calculated point;
- 5. North 77°49'59" East a distance of 60.24 feet to a calculated point in the East line of the 134.62 acre tract and in the West line of Lot 26, Jackie Thomison Subdivision, a

subdivision of record in Cabinet I, Slides 94-96 of the Plat Records Williamson County, Texas;

THENCE along the east line of the 134.62 acre tract and the west line of said Jackie Thomison Subdivision South 12°11'04" East a distance of 518.48 feet (record South 09°35' East a distance of 518.48 feet);

THENCE crossing through the 134.62 acre tract along the North line of a 100 foot wide Electric Easement conveyed to Texas Power and Light Company in Volume, 233 Page, 469 Deed Records Williamson County, Texas and to Oncor Electric Company LLC. In Document Number 2009085396 Official Public Records Williamson County, Texas, South 80°08'57" West a distance of 1313.52 feet to a calculated point in the west line of the 134.62 acre tract and being in the east line of the 33.302 acre tract;

THENCE along the west line of the 134.62 acre tract and the east line of the 100 foot wide Railroad Right of Way the following three (3) courses:

- 1. North 02°06'14" West a distance of 335.30 feet to a 1/2" rebar found for a point of curvature;
- 2. Along a tangential curve to the right, having a radius of 5679.65 feet (record: 5679.65 feet), a length of 820.14 feet (record: 820.29 feet), a delta angle of 08°16'25" and a chord which bears North 01°48'58" East a distance of 819.43 feet (record: North 01°48'10" East a distance of 819.57 feet) to a 1/2" rebar found for a point of tangency;
- 3. North 04°51'51" East a distance of 210.18 feet (record: North 07°29'20" East a distance of 212.35 feet) to the POINT OF BEGINNING.

This tract contains 30.36 acres of land, more or less, out of the Willis Donaho Survey, Abstract Number 173 in Williamson County, Texas. Bearing Basis: Texas State Plane Coordinates, Central Zone, NAD 83\96, CORS.
