THENCE, crossing said 60 acre tract, S68°38′27″W, a distance of 1965.44 feet to a calculated point, being a point on a southwest boundary line of said 60 acre tract and being also a point on a northeast boundary line of a called 10.010 acre tract of land described in the Declaration of Condominium Regime for High Rock Business Park in Document Number 2018016217 (O.P.R.W.C.TX.), for the south corner of the herein described tract,
