Along a tangential curve to the right, having a radius of 5679.65 feet (record: 5679.65 feet), a length of 579.99 feet (record: 579.99 feet), a delta angle of 05°51'04" and a chord which bears North 00°36'17" East a distance of 579.74 feet (record: North 01°48'10" East a distance of 579.74 feet) to the POINT OF BEGINNING.
