THAT PART OF THE HENRY MILLARD SURVEY, ABSTRACT NO. 452, IN WILLIAMSON COUNTY, TEXAS, BEING A PART OF THAT 168.558 ACRE TRACT OF LAND AND BEING ALL OF THAT 21.511 ACRE TRACT, BOTH CONVEYED TO JSL NORTH INVESTMENTS, LLC BY DEED RECORDED IN DOCUMENT NO. 2017057905 OF THE OFFICIAL PUBLIC RECORDS OF WILLIAMSON COUNTY, TEXAS (OPRWC), AND BEING COMPRISED OF TWO PARTS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

PART 1- 12.80 Acres

BEGINNING at a 1/2" iron rod found on the east line of said County Road 110, being also at the southwest corner of this tract;

THENCE N21°23'26"W along the east line of County Road 110 and the west line of said 168.558 acre tract a distance of 378.87 feet;

THENCE across said 168.558 Acre Tract the following 15 courses:

4. Easterly along the arc of said curve, a distance of 122.15 feet, said curve having a radius of 450.00 feet, a central angle of 15°33'10" and a chord bearing N79°05'26"E, 121.78 feet;
5. N71°13'14"E a distance of 168.41 feet;
6. S17°59'35"E a distance of 0.27 feet;
7. S22°04'44"E a distance of 50.09 feet from which a 1/2" iron rod found on the north line of University Boulevard, same being on a southerly angle point of said 168.558 acre tract bears, S42°43'06"E a distance of 356.46 feet;
8. S71°18'50"W a distance of 15.03 feet to a point of curvature of a curve to the right;
9. S22°04'44"E a distance of 183.03 feet;
10. S23°30'23"W a distance of 84.85 feet;
11. S21°29'37"E a distance of 15.00 feet;
12. S68°30'23"W a distance of 698.41 feet;
13. S68°46'54"W a distance of 160.56 feet;
14. S68°32'52"W a distance of 724.12 feet;
15. N66°28'07"W a distance of 29.53 feet to the said Point of Beginning.




